MUNICIPAL SOLID WASTE COLLECTION RULES

Single Family Residential Homes



PLEASE NOTE: The rules below are basic and may not cover all solid waste generated in the Village of Saukville. Regulations pertaining to recyclables are listed separately.

APPROVED CONTAINERS FOR COLLECTION OF SOLID WASTE AND RECYCLABLES:

- Contractor supplied 96 or 65 gallon wheeled carts.
- No other containers are allowed as collection is now performed by an automated cart system.
- **CARTS MUST FACE THE STREET AS INDICATED BY ARROW ON CART, MUST BE FULLY ACCESSIBLE, CAN NOT BE BLOCKED BY PARKED VEHICLES, AND NEED TO BE PLACED SIDE BY SIDE WITH A MINIMUM OF THREE (3) FEET OF SPACE BETWEEN CARTS AND/OR OTHER OBSTACLES.**

All containers must be curbside by 6:00 a.m. on scheduled collection day.

1. BASIC SOLID WASTE RULES:

A. **Garbage Waste:** Plastic bags are optional in placing your waste in the cart. Carts will remain clean longer, if waste is bagged.

B. **Ashes or Burnt Materials:** Shall not be put in cart.

C. Construction Waste:

1. Material generated from **residents performing their own work** will be collected provided such materials are able to be placed in cart and do not prevent the lid from being substantially closed.

2. Material left outside of the container will not be collected.

D. Miscellaneous Information:

1. Bulk Waste: Items such as furniture, carpeting, fixtures, microwaves, lumber, etc, will be collected as long as it fits in the container.
2. Bulk pickup for large items may be called into 1-800-387-0949 and will be charged an additional fee to remove.
3. Drop off of large items may be taken to the **West Bend Transfer Station** At 803 N River Road, West Bend WI 53090 for a minimum fee.

4. **NO** tires will be accepted in trash pickup.
5. **NO** Lead Acid Batteries Collected.
6. **NO** Waste Engine Oil Engine or Anti-Freeze will be collected.
7. **No** free flowing liquids.

E. **Paint:** Paint cans must have paint in a dry or hardened state. Add floor Oil Dry Or cat litter to dry.
