The Village of Saukville Business Development Loan Program was established to encourage revitalization efforts, increase capital investments, and provide support for new and existing businesses in the commercial districts and developing area of the Village of Saukville.

The Village of Saukville Business Development Loan Program can be used as a primary loan and is also available to be used in conjunction with other loans and financing to aid in project completion. Interest rates can be as low as 1.00%. Each loan is evaluated separately on collateral, risk and terms. Loans are generally not less than \$5,000, or more than \$50,000, subject to the availability of funds in the loan pool.
